Consumer Protection and Redressal Procedure

In the club meeting on June 8, 2007, Brig. J.S. Phoolka (Retd.), Chairman, Consumer Forum, Chandigarh gave a talk on Consumer Protection & Redressal. The Guest Speaker was introduced by Rtn. Arjan Singh. After passing out from NDA & IMA, Brig. Phoolka was commissioned into the Gunners. He served the army in various Command & Staff assignments, and took part in the 1962, 65 & 71 operations. He took pre-mature retirement from the army in 1992. Having done MSc & Staff College Course, Brig. Phoolka is presently pursuing a doctoral research. He is also associated with number of other NGOs.

Brig. Phoolka was accompanied by other members of Consumer Forum Chandigarh; Mr. R.K. Kaplash, Sr. Vice Chairman, Mrs Amrita Sehgal, Vice Chairman, Mr. H.S. Ahluwalia, Secretary General, Mr. Thakur Singh, Secretary Finance, Mr. B.M. Mittal, Organising Secretary and Mr. H.S. Walia, Legal Adviser, who enlightened us on the Consumer Protection Act.

Brig. Phoolka said that Consumers Forum Chandigarh (CFC) was founded in the year 1979 by Late Lt. Gen. Sartaj Singh (George Medal, Padma Bhushan). In those days of 'Inspector Raj' consumers were facing difficulties in procurement of even basic ration items. CFC provided relief to the consumers in solving their day to day problems with the help of officials of Chandigarh Administration. 'Apni Mandi' - a novel method of making fresh vegetables & fruits available to the consumers was started in the city where the producer / farmers could sell their produce direct to the consumers

'Apni Mandis' are very popular even today. Consumers Forum Chandigarh mainly promotes the understanding of the rights of the consumers.

The Consumers Protection Act, 1986 is a milestone in the history of socio - economic legislation of the country. It is one of the most progressive and comprehensive pieces of legislation enacted for the protection of the consumers. The new law has been enacted after in-depth study of consumer protection arrangements in the UK, USA, Australia and New Zealand.

The main objective of the Act is to provide for the better protection to the consumers. Unlike existing laws which are punitive or preventive, the provisions of this Act are compensatory in nature. The act intends to provide simple, speedy, & inexpensive redressal to the consumers grievances. For this purpose, the Act envisages a three tier quasi-judicial Redressal Forum at the National, State & District levels.

All of us are consumers of goods and services. In the Consumer Protection Act, the consumer means a person who buys any goods for a consideration. It also includes the service hired for consideration. The Act enshrines the following rights of the consumer:

- ★ The right to be protected against the marketing of goods which are hazardous to life & property.
- ★ The right to be informed about the quality, quantity, potency, purity, standard & price of goods so as to protect the consumer against unfair trade practices.

- ★ The right to be assured, whenever possible, access to a variety of goods at competitive prices.
- ★ The right to be heard and to be assured that consumer's interests will receive due consideration at the appropriate forums.
- ★ The right to seek redressal against unfair trade practices or unscrupulous exploitation of consumers.
- The right to consumer education.

Alternate Dispute Resolution is a method adopted by Consumers Forum Chandigarh for Redressal of complaints by arbitration. The disputes are settled out of the court by negotiations and counseling. Consumers Forum Chandigarh have borrowed this system from America & have so far settled 10000 complaints of the consumers without any charge from the consumer or the opposite party. In this manner consumer's complaints have been settled against Govt. Departments like PUDA, HUDA, DDA, Postal Dept., Telecom Dept., Insurance Companies, University, Banks, traders, doctors, lawyers, booking amount for Vehicles, finance companies etc.

In Alternate Dispute Resolution, the complaints are settled most expeditiously and without any cost burden on the complainant. The requirement of documents is minimum. Whereas for the Redressal Forum a number of copies of complaints, cash memos and correspondence exchanged are required to be attached. The settlement by CFC is immediate, whereas decisions given by the Redressal Forum are implemented within a time frame which in many cases may be delayed.

In Alternate Dispute Resolution the success rate of CFC has been approximately 70%. For the balance 30% where no settlement could be made due to adamant attitude of the parties, CFC guides the consumer to file a complaint with the Consumer Disputes Redressal Forum. CFC is functioning from Karuna Sadan, Sector 11, Chandigarh.

On matters of important consumer issues when CFC fails to get a positive response from the service providing departments, they take the matter to the court. In 2001 a P.I.L. was filed against the Municipal Corporation Chandigarh for unjustly passing on the responsibility for replacement of defective water meters to the consumers who had been regularly paying meter rent to the Corporation for the last 45 years. It was proved in court that the amount received by the Corporation was more than sufficient for the replacement of defective water meters. The court gave the verdict that Municipal Corporation would continue maintaining the water meters and consumers would not be harassed for this service.

PP Ar. Pallav Mukherjee, Nominated Councillor of Municipal Corporation Chandigarh proposed vote of thanks, but only after briefly highlighting the grievances of an ordinary citizen with respect to functioning of MCC!
